## **2022 Annual Tax Documents -FOR YOUR RECORDS**

Tax documents will be mailed to the Participant's most current valid address on file with our office by January 31, 2023. Please be aware that the Trust Fund Office does not have any control on the length of time it will take for you to receive document(s) through the mail due to the high volume of tax documents being handled by the United States Postal Service. Since document(s) will be mailed by January 31, 2023, we will not be able to provide duplicates until after February 15, 2023.

Tax documents that you may receive from the Trust Fund Office include:

- 1099-Rs issued to anyone who received a Retirement Benefit in 2022.
- W-2s issued to anyone with a Domestic Partner enrolled in 2022.
- Annual Dues Statements issued to Participants who worked during the period of December 2021 through November 2022 (for UA Local 342 members, amounts can also be reviewed through ISITE).

Please note that any 1095 Tax Forms will be sent directly to you from your Health Plan (Kaiser Permanente or Blue Shield of California).

As a reminder, representatives from the Trust Fund Office and UA Local 342 are not able to assist you with any tax questions or interpretation of tax laws. You would need to seek assistance and discuss all tax matters with your Tax Advisor.



## CORRECTION TO 12/2022 FAQ:

#### What is my Retirement effective date?

A Participant's earliest eligible Date of Retirement is generally the first of the month following the month the Participant has met all Plan requirements, including submitting a completed Application.



#### When should I submit my Retirement Application?

It is suggested that you submit your Application 60 days prior to your anticipated Date of Retirement.

#### How are Retirement Benefits Issued?

Retirement Benefits are issued via Electronic Funds Transfer ("EFT"). In order to increase efficiencies and reduce the risk of theft, the Plan requires EFT of all Retirement Benefits. An EFT Statement confirming the transaction is mailed each month.
