2021 Annual Tax Documents- Reminders



Tax documents were mailed January 31, 2022, to the Participant's most current valid address on file with our office. For a list of tax documents that you may receive from our office please see the January 2022 Blueprint Article. Any 1095 Tax Forms will be sent directly to you from your Healthcare Plan (Kaiser Permanente or Blue Shield of California). Please note that, due to the high volume of tax documents being handled by the United States Postal Service at this time, there may be delays in receiving the documents. We will not be able to provide duplicates until after February 15, 2022.

As a reminder, representatives from the Trust Fund Office and UA Local 342 are not able to assist you with any tax questions or interpretation of tax laws. You would need to seek assistance and discuss all tax matters with your Tax Advisor.



Did Your Phone Number or Email Change?



Be sure to notify our office if you have changed your phone number or email address. You can contact our office at (925) 356-8921. If you reach our voicemail system, please leave a message, providing a valid telephone number and your message should be returned within one (1) business day.

Have you cleaned up your voicemail lately? We are often unable to leave a message when returning calls, due to voicemails being full or not set up. If you leave a voicemail with our office for a call back, please make sure that our office can leave a message on the number that you left.

I need to change my address on file.

In order to change your address, you will need to fill out a new Enrollment/Change Form (unless you are not enrolled in Health and Welfare Plan, then it will be a Change Request Form). These Forms can be found on our website (www.ncpttf.com). The Enrollment/Change Form will need to be completed in its entirety; including listing all eligible Dependents, the new address, signed, and dated. We cannot take address changes over the phone due to the risk of fraud. Please note, you will need to contact the UA Local 342 Office separately from the Trust Fund Office.
